Sub : Modification in policy for provision of pre-paid SIM with a talk time of Rs. 200/- p.m. to Telecom Mechanics / Regular Mazdoors who undertake out door duties and select non Executives on the basis of functional need -reg.


Vide PHA Circular No. 04/2011-PHA dated 16.01.2012 Telecom Mechanics/Regular Mazdoors who undertake outdoor duties and select Non-Executives on the basis of functional needs were allowed pre-paid GSM Sim with a talk time of Rs 200/-p.m with CUG facilities free of cost within the SSA in the area where CDMA coverage is not available or handsets are not available. The connection was restricted to level "2" of BSNL only and access to level "9" including "94" of BSNL as well as any other level of private operator was barred.

2. Requests have been received from some Circles, Unions as well as through National Council requesting for modifications in these instructions. The Management Committee in its 150th meeting held on 2nd November, 2012 has considered the above requests and has taken a decision that

- (a) Circles Head may be empowered to decide for providing free SIM with a talk time of Rs. 200/- p.m. to all outdoor staff including TTAs even if the CDMA coverage is available. However utility of CDMA handsets becoming spare should be ensured and
- (b) The "94" facility (which also include other BSNL Mobile levels in that SSA) with CUG within the SSA level including free roaming but without STD may be extended to all such SIM Card holders
- (c) Free talk time including the free roaming with the connection shall be for ON-NET calling only.

The other terms and conditions will remain the same as per Circular No 04/2011-PHA dated 16.01.2012.

These instructions will come into force with immediate effect
