Sub:- Provide Fitment to all TTA's recruited upto 07/05/2010 (date of issuing of wage-revision-order)

On 25<sup>th</sup> June 2010 our GS Mr. Dharmendra Verma Ji has written a [letter](#) to you with demanding to include "Fitment-Benefit to all employees recruited between 01-01-2007 & 07-05-2010" in forthcoming 24<sup>th</sup> NCM. Then a meeting held between SNATTA & BSNLEU at New Delhi on 12<sup>th</sup> July 2010, and it was decided that UF will fight for the above issue. Then on 23<sup>rd</sup> July 2010 a [notification](#) for agitational programme (Demonstration on 05<sup>th</sup> Aug 2010 & Dharna on 12<sup>th</sup> Aug 2010) issued from UF to management including above demand (Demand No. 3). Then management has called UF leaders to talk on the issues of proposed agitation on 09<sup>th</sup> Aug 2010. But in the [minutes](#), the matter comes with GRANT PAY-PROTECTION instead of FITMENT-BENEFIT.

Sir, what happened between 25<sup>th</sup> June 2010 & 09<sup>th</sup> Aug 2010 that the issue of demanding FITMENT-BENEFIT became demanding PAY-PROTECTION. I just want to remember you our demands. Pls. do not change our demand on the meeting-table suddenly. We are very hopeful to all UF leaders with our demand, as it is logical & genuine.

NCM is proposed on 31<sup>st</sup> Aug 2010, on this day all UF leaders should demand for FITMENT-BENEFIT not for PAY-PROTECTION (as it was decided between SNATTA & BSNLEU on 13<sup>th</sup> July 2010).
